### DECLARATION OF PRINCIPLES

The objective of this Quality, Environmental and Ecodesign Policy is to achieve this reality. In order to accomplish these objectives, the Management establishes the following principles:

- Protect the environment and contribute to the prevention of pollution, working to minimize its significant environmental aspects: consumption, waste and emissions. In this sense, ensure compliance with environmental regulations, paying special attention to general and product environmental impacts, social responsibility and workers' health and safety.
- Comply with current legislation and other requirements established by customers and other interested parties, meeting their needs and expectations.
- Count with the participation and commitment of all the company's personnel, as well as visiting personnel, striving for **continuous training**.
- Comply with the requirements applicable to our Management System, especially **customer satisfaction and product safety for consumers**, with whom they are fully committed.
- The organization assumes the ideal of **Continuous Improvement** as a necessary requirement for the effectiveness and efficiency of the Management System and product throughout its life cycle, present in all its processes, developments, products and services.
